If you do not purchase optional Loss Damage Waiver, you may be responsible for the full cost of any and all repairs or the full replacement cost of the equipment. The waiver is subject to the exclusions in paragraph 12 of the Rental Agreement. The Loss Damage Waiver fee will be twelve (12) percent of the rental charges and would be subject to a minimum deductible as outlined in paragraph 12 of the Rental Agreement.

**Open Account Credit Terms**

- Each invoice is payable and due 10 days from the date of the invoice.
- If equipment is rented for more than 4 weeks, periodic unsigned invoices will be issued for rental charges due. All such invoices are payable and due within 10 days of the invoice date.
- At the discretion of Taylor Rental, any account with a delinquent balance may be placed on a cash basis at anytime, and the equipment picked up without notice.
- Taylor Rental files preliminary lien notices and mechanics' liens whenever necessary or required by law. This is Company Policy, and is not a reflection of your credit standing or rating. The undersigned agrees to furnish Taylor Rental with accurate information necessary to complete the notices or liens.
- Customer agrees to pay on each delinquent account a monthly service charge of 1 1/2% or the maximum permitted by law in the state where the contract is signed. A fee of \$25 will be charged for all N.S.F. Checks.
- Customer agrees to pay all reasonable attorneys fees, collection cost, and court cost incurred by Taylor Rental in enforcing these terms and conditions.
- Customer authorizes Taylor Rental to obtain credit reports, trade reports, and bank references for the purpose of determining the extension or continuation of credit.

The undersigned warrants that all information is correct, has read, accepted and agrees to be bound by all of the above terms and conditions set forth in this document and in each rental contract ordered by the undersigned or his agents. It is understood and agreed that the undersigned specifically consents to Taylor Rental's investigation of the applicant's credit history and may utilize credit-reporting services for information on the undersigned.
